

CORPORATE ENVIRONMENTAL POLICY

The cornerstone of Tozzi Green S.p.A.'s mission is to partner companies and regional agencies in creating a world that runs on clean energy, in implementing a new growth model based on economic development, social progress and environmental friendliness.

In particular, the aim is to favour the development of communities by preserving and protecting environment, biodiversity and ecosystem. Tozzi Green S.p.A. is strongly committed to the health and welfare of its employees, contractors and visitors; hence, safeguarding the working and living environment is crucial to achieve this goal. During all phases of project development, Tozzi Green S.p.A. maintains keen focus on ensuring high standards in terms of environmental responsibility, making remarkable efforts to substantially reduce any potential environmental impact.

The company's duties and objectives are described below:

- 1. Promote **respect for and preservation of the environment**, building employee, contractor and visitor awareness about the importance of avoiding energy and water wastage;
- 2. Promote the adoption of models based on **circular economy**, which, underpinned by a transition to renewable energy sources, work around the three following principles: design out waste and pollution, keep products and materials in use, regenerate natural systems;
- 3. Reduce the quantity of garbage to an ALARP level by enforcing recycling and reuse, starting from separate waste collection;
- 4. Carry out an environmental impact assessment in order to identify, assess and control the risks and effects of its activities and those which can be influenced by Tozzi Green S.p.A. through the adoption of principles, standards and the most advanced operating practices designed to ensure respect for the environment and preservation of biodiversity and of ecosystems;
- 5. **Maintain and improve air quality** on the one hand by respecting emission limits established by the legislation in force and, on the other hand, by implementing the best technical engineering solutions to reduce the discharge rate of contaminants into the atmosphere;
- 6. **Respect noise limits** defined by the local legislation for working and living environments, keeping them at a level that is not potentially hazardous for both local communities and natural ecosystems;
- 7. Avoid and prevent any discharge or accidental leakage of hazardous products by implementing a hazard prevention response and incident management system that defines all actions to be carried out in case of an environmental emergency in order to minimise the effects and conduct a thorough incident investigation in view of preventing any future reoccurrence;
- 8. **Prevent soil and groundwater contamination** by providing the necessary areas and equipment required to safely store hazardous substances and/or hazardous waste;
- 9. Conduct environmental monitoring to ensure the implementation of environmentally sound industrial processes, in compliance with local legislation and international standards.

Tozzi Green S.p.A. is also responsible for recognising and responding, with appropriate and timely information, to any legitimate community concerns about potential environmental impacts.

Tozzi Green S.p.A.'s Management aims at increasing the effectiveness of its integrated QHSE Management System in order to improve its performance, as well as to promote extensive dissemination of this Policy within the Company, and to make it available to relevant stakeholders. Provisions laid down by the Corporate Management System shall be considered as applicable to employees, contractors and partners working for Tozzi Green S.p.A. or its subsidiaries.
